US FDA Compliance	All raw materials in this product are in compliance with FDA (Food and Drug Administration in the USA) 21 CFR parts 170 to 199. Test conditions for overall migration were OM0 (30 min at 40 °C) Food simulants used for overall migration were 50 % ethanol (simulant D1) and 3 % acetic acid (simulant B). Compliance with specific migration limits, and other restrictions, has been documented through testing, calculation or simulation.

General

The product is suitable for repeated use under the conditions specified in this Declaration of Compliance. Reuse does not affect the product's compliance with applicable food contact regulations, provided it remains intact, undamaged, and is cleaned appropriately between uses.
