<b>UK Compliance</b>	The product complies with The Materials and Articles in Contact with Food (Amendment) (EU Exit) Regulations 2019 No. 704.
<b>Danish Compliance</b>	The product complies with the Danish consolidation Act no. 681 of 25/05/2020.
<b>Japanese Compliance</b>	All substances (polymers, monomers and additives) used in Vikan products comply with Article 18(3) of the Japanese Food Sanitation Act and are listed in Tables 1 and 2 of Appendix 1 of the Positive List.
<b>Migration analysis plastics</b>	<p>Samples of the product, or a similar product made from identical plastic material, have been tested for overall migration according to the test conditions specified in (EU) 10/2011 for repeated use, and the article comply with the overall migration limit of 10 mg/dm<sup>2</sup> or 60 mg/kg.</p> <p>Compliance with specific migration limits, and other restrictions, has been documented through testing, calculation or simulation.</p> <p>Food simulants used for overall migration were 10 % ethanol (simulant A), 3 % acetic acid (simulant B) and olive oil (simulant D2).</p> <p>Test conditions for overall migration were OM2 (10 days at 40 °C)</p>

**General**

We will make the relevant background documentation available to the competent authorities, at their request.

Vikan A/S is registered with the Danish Veterinary and Food Administration (DVFA), and our mandatory Own Control System is subject to inspection by the DVFA.

The product is suitable for repeated use under the conditions specified in this Declaration of Compliance. Reuse does not affect the product's compliance with applicable food contact regulations, provided it remains intact, undamaged, and is cleaned appropriately between uses.
